- Notifying us immediately of unauthorized access

We may suspend or terminate accounts for suspicious activity or violation of these Terms.

5. Payment, Subscriptions & Commitment Period

5.1 Subscription

Coaching and app access operate on a monthly subscription billed automatically through Stripe.

5.2 Commitment Period

All services include a **minimum binding period**, depending on the program chosen:

Minimum: 3 monthsMaximum: 10 months

You agree to pay for the full commitment period even if you stop using the Services before it ends.

5.3 Automatic Renewal

Subscriptions automatically renew monthly after the commitment period unless cancelled.

If you do not wish to renew, you must provide minimum 30 days written notice before your next renewal date.

5.4 Right of Withdrawal

In compliance with European consumer law:

- You receive a **14-day right of withdrawal** when you first sign up.
- This does not apply after you receive access to personalized services, programs, or coaching, because customized digital content is legally exempt from withdrawal once delivered.

5.5 Refunds

Refunds are only provided in cases of:

- Billing errors
- Mistaken charges

Refunds are **not** issued for:

- Failure to use the service
- Change of mind
- Partial use of a subscription period
- Early termination during a binding period

6. User Responsibilities

You agree to:

- Provide accurate information, including health, fitness level, and relevant personal data
- Follow instructions and program guidelines to the best of your ability
- Use the App and Services responsibly and lawfully
- Not share your account with others

- You acknowledge that all exercise carries risk, and you participate voluntarily.

9. Use of the App

You agree not to:

- Misuse or interfere with the App's functionality
- Attempt to reverse engineer or modify the App
- Upload harmful or unauthorized content
- Use the Services for illegal or commercial purposes

We reserve the right to restrict or terminate access at any time if these rules are violated.

10. Termination

We may immediately terminate or suspend access if:

- You violate these Terms
- You misuse the App or coaching platform
- Payments fail or remain unpaid
- Fraudulent or unsafe behavior is detected

You may cancel your subscription according to Section 5.

11. Push Notifications & Health Data Sync

The App may send push notifications for:

- Workout reminders
- Coaching updates
- Account information
- Program guidance

The App may also sync data from health platforms (when enabled by you).

You may disable notifications or data syncing in your device settings, but certain features may not function properly.
